# **Addendum D - Pregnancy Register and Covid Vaccinations**

#### 1. Overview

This Addendum sets out the additional work to flow in a pregnancy register into CIPHA to link with other datasets so we can get accurate vaccine uptake rates and enhanced intelligence on this cohort.

There are safety concerns with current uptake rates leading to serious harm and even mortality in some cases, and so the quicker we can mobilise this the better for our C&M population.

Directors of Public Health are pushing for this, as is the Covid Vaccine Programme.

Ultimately there is no new parties to the agreement. This is a data flow from our existing partner Trusts into CIPHA, but because it is a new dataset, we need this Addendum.

#### 2. Lawful Basis

This Project is covered by the Control of Patient Information Notice (COPI) for COVID, under Regulation 3(4) of the Health Service Control of Patient Information Regulations 2002.

6(1)(e) Necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller.

### **Processing Sensitive Personal Data – Article 9**

9(2)(h) Necessary for the reasons of preventative or occupational medicine, for assessing the working capacity of the employee, medical diagnosis, the provision of health or social care or treatment or management of health or social care systems and services on the basis of Union or Member State law or a contract with a health professional.

9(2)(i) Necessary for the reason of public interest in the area of public health, such as protecting against serious cross border threats to health or ensuring high standards of healthcare and of medicinal products or medical devices.

Data will flow from our existing partner Trusts into CIPHA.

- To create an accurate understanding of covid vaccination rates for pregnant women in order to manage clinical risk in low vaccination rates
- To link toother datasets to understand the epidemiology of pregnant populations with low uptake and target communications effectively
